**Ron Webb** spoke on Services provided by CPS:

They service 13 counties in Kentucky-Eastern Mountain Region.

Do calls on APS (Adult Protective Services):

1. Kentucky Had 72,539 APS calls from Nov. 2012 to Oct. 2013
2. Debbie Price is the Supervisor ( 788-7100)
3. To make referrals call 788-7132.
4. Calls that are APS/CPS can get help in the home faster.
5. Most vulnerable group in our area is cases that involve homes with children under 3.
6. Have a new web based site to report , have to leave name and number for this reporting service ,(CHFS.Gov)
